TCH Coop Behavior Agreement

Our mission is to provide educational, character-building, and social activities that honor God and enhance our homeschooling experience. Our goal is to teach our students to be an example in speech, conduct, love, faith and purity as stated in 1 Timothy 2:14. Our rules and expectations are meant to guide them in that goal.

Student Participation

Every student will :

1. Come prepared for class
2. Participate and follow directions
3. Respect church / school property
4. Always treat others with respect and courtesy
5. Remain with parents or designated area when not in class
6. Dress appropriately for modesty, weather & PE

The following plan is in place when a student is needing to be corrected :

1. 1st notice - The student will be taken aside and counseled.
2. 2nd notice - The parent will be contacted and asked to intervene.
3. 3rd notice - The student may be removed from the coop with no refund.

Parent Participation

1. One parent or guardian must remain on-campus for the duration of the coop and will be expected to contribute as assigned. Each family must contribute to cleaning the facility every week.
2. A background check form **MUST** be filled out for each parent in order to participate or be in the building.
3. Please remember to **LIMIT** cell phone use during the entire day. Our focus during this time should be completely on the children.
4. Each parent should instruct their students to remain in the main assembly room before coop and at the end of the day. At least one adult should be in the room at all times. Babies and toddlers may be taken to their classrooms but should **NEVER** be left in a room without a teacher.
5. You will agree to the Statement of Faith or agree not to speak or teach anything contrary to it while on campus.
6. Each family must provide the textbooks required for the classes their children are taking and pay the non-refundable registration and class fees. The registration fee **MUST** accompany the registration form. Class fees are due on or before orientation. Only one textbook per family per subject is required.
7. You **MUST** contact the Administrative Team as soon as you know you will not be at coop due to illness or other matters out of your control by text, phone call or direct message.
8. You must ensure that your responsibilities for the day are taken care of and any items needed are handed off to your backup before class begins.

TCH Coop Statement of Faith

1. We believe that the 66 books of the Old and New Testaments stand alone as the inspired, inerrant, and authoritative Word of God (2 Tim.3:16, 2 Pet. 1:21).
2. We believe that there is but one God eternally existent in three persons: Father, Son, and Holy Spirit, who is perfect, holy, and sovereign; the Creator, Preserver, and Ruler of all things (Gen.1:1, Mt. 28:19, Jn. 10:30).
3. We believe in the literal Biblical account of creation as set forth in Genesis 1 & 2.
4. We believe that man was originally created in the image of God but, because of the temptation of Satan, sinned against God and is therefore lost and separated from God. The only way one can be saved from eternal death and restored to God is by placing his faith in the saving work of Jesus Christ alone (Gen. 1:26, Gen. 3, Rom. 3:10-28).
5. We believe in :
 - the deity and humanity of our Lord Jesus Christ who is the only begotten Son of God (Jn. 10:30,33; Rom. 9:5)
 - in His virgin birth (Mt. 1:23)
 - in His sinless life (Heb. 4:15)
 - in His miracles (Jn 2:11)
 - in His vicarious and atoning death through His shed blood (1 Cor. 15:3, Eph. 1:7, Heb. 2:9)
 - in His bodily resurrection (Jn. 11:25, 1 Cor. 15:4)
 - in His ascension to the right hand of the Father (Mk. 16:19), and
 - in His personal and physical return in power and glory (Acts 1:11, Rev. 19:11).
6. We believe that for the salvation of lost and sinful man, regeneration by the Holy Spirit is essential, and that this salvation, which is a gift of God's grace, is received through faith alone in Jesus Christ as Savior and Lord, and not as a result of good works (Jn.3:16-19, Rom. 3:23, Eph. 2:8-10).
7. We believe in the resurrection of both the saved and the lost: the saved unto the resurrection of life, and the lost unto the resurrection of damnation (Jn. 5:28-29).
8. We believe in the current ministry of the Holy Spirit, which is to convict, indwell, teach, guide, and empower the believer to perform good works and live a godly life (Rom. 8:13-14, 1 Cor. 3:16, Eph. 4:30).
9. Biblical marriage and sexuality.

Statement on Marriage, Gender and Sexuality

We believe that God wonderfully and immutably creates each person as male or female. These two distinct, complementary genders together reflect the image and nature of God. (Genesis 1:26-27). Rejection of one's biological sex is a rejection of the image of God within that person.

We believe that the term "marriage" has only one meaning: the uniting of one man and one woman in a single, exclusive union, as delineated in Scripture (Gen. 2:18-25). We believe that God intends sexual intimacy to occur only between a man and a woman who are married to each other (1 Corinthians 6:18, 7:2-5; Hebrews 13:4). We believe that God has commanded that no intimate sexual activity be engaged in outside of a marriage between a man and a woman.

We believe that any form of sexual immorality (including adultery, fornication, homosexual behavior, bisexual conduct, bestiality, incest, and pornography) is sinful and offensive to God (Matt. 15:18-20; 1 Corinthians 6:9-10). We further believe that any form of advocacy of such conduct is also sinful (Romans 1:32).

We believe that in order to preserve the function and integrity of Texoma Christian Coop as a ministry to provide a biblical role model to our members and the community, it is imperative that all persons enrolled as students, teachers, or volunteers agree to abide by this Statement on Marriage, Gender, and Sexuality (Matt 5:16; Phil. 2:14-16; 1 Thessalonians 5:22).

We believe that God offers redemption and restoration to all who confess and forsake their sin, seeking His mercy and forgiveness through Jesus Christ (Acts 3:19-21; Rom. 10:9-10; 1 Corinthians 6:9-11). We believe that every person must be afforded compassion, love, kindness, respect, and dignity (Mark 12:28-31; Luke 6:31). Hateful and harassing behavior or attitudes directed toward any individual are to be repudiated and are not in accord with Scripture nor the doctrines of Texoma Christian Coop.
